Throughout this annual report, you will find examples of our Board, staff, medical staff, volunteers, donors, and community partners working together to provide the kind of excellence and value in the care we provide which earns national recognition. NMC achieved the prestigious "Most Wired" designation for the integration of our Information Systems throughout all we do. We had a very positive and successful accreditation survey by the Joint Commission.

With an eye to improved quality of life and reduced demand for costly treatment, NMC has worked with the Vermont Department of Health and the Community Committee on Healthy Lifestyles on the launch and expansion of the



### exciting RiseVT community campaign. Individuals, families, businesses, schools, and municipalities throughout our region are embracing healthy lifestyles. These efforts earned a remarkable score in a formal review by EPODE, an international leader in reducing childhood obesity.

As we continue forward into FY'17, we are actively engaged in Vermont's efforts to shift from fee-for-service medicine to an emphasis on population health. ### Addressing the Top Health Needs of Our Community

In 2016, NMC conducted a new Community Health Needs Assessment – a process undertaken every three years gathering critical information from public health experts, departments, agencies, community leaders, representatives of medically underserved groups and many more.

This new assessment identified six top priorities that will inform our healthcare efforts in the coming year:

- 1. Mental Health & Substance Abuse
- 2. Obesity
- 3. Smoking
- 4. Cancer
- 5. Suicide
- 6. Domestic & Sexual Assault

NMC has already taken key steps forward in the four top priorities of combating substance abuse, getting people active, encouraging healthy eating, offering tobacco cessation programs and early detection for cancer whenever possible. We also work closely with community partners on suicide and physical violence through our Emergency Department and other front-line interactions with our patients.

The stories on these pages outline our progress in the past year toward addressing these critical priorities as we also look ahead to the future.

### **RiseVT: Strides Toward** a Healthier Community

This year, RiseVT made huge strides toward a healthier community reaching out to more than 13,000 community members to encourage them to take their first steps on a wellness journey. RiseVT is a community collaborative that focuses on embracing healthy lifestyles, improving quality of life, and lowering healthcare costs.


The collaborative applies that mantra in the places we live, work, learn, and play. This multi-directional approach brings attention to healthy lifestyles in schools, businesses, municipalities and directly to individuals. When we are surrounded by healthy messages in all aspects of our life, healthy choices are easy to make.

Here are some of the concrete impacts RiseVT has had this year in each of its four core channels:

- RiseVT in Businesses: 46 local businesses implemented wellness programs. This far surpasses RiseVT's goal of engaging 20 local businesses to implement wellness programs for the first year.
- RiseVT in Schools: Fifteen schools implemented Safe Routes to School to encourage walking as a healthy physical activity for students and staff.
- RiseVT in Communities: Nine municipalities are engaged with RiseVT, implementing wellness programs and putting policies in place that create healthy environments for the whole community.
- RiseVT for Individuals: 1,100 people have completed scorecards as a self-assessment of their own wellbeing and 176 have met with a RiseVT health coach to take action to improve their score, and their health.

These impressive accomplishments during RiseVT's first year match the urgency Vermont feels to address the obesity trend, and move healthcare toward a prevention-based model. Not only was this first year a foundation-building time for RiseVT which hired five staffers and put those people to work immediately in their communities, the collaborative also set its sights on the future.

### **Tobacco Use in Franklin and Grand Isle County**

### **Successes and Future Focus**

The Franklin Grand Isle Tobacco Prevention Coalition, in partnership with the State of Vermont's Tobacco Control Program and NMC with its strong commitment to reducing the negative impact of tobacco use has been working for 15 years to help protect our residents. There have been great successes!


Youth regular cigarette use is down to a low of 11% in Franklin County – and down from 27% in 2001.

Unfortunately, youth are reporting using some form of tobacco products in the past 30 days. In fact, 27% of Franklin County youth reported using some form of tobacco products, including vaping or e-cigarette products, in the past 30 days. That's more than <sup>1</sup>/<sub>4</sub>!

Adult cigarette use is also down from its high of 25% in 2000-2002, but has remained relatively flat between 18-20% for the past 10 years. Fortunately, 57% of Franklin County residents reported making a quit attempt in the past year – and that's our second highest rate yet! Quitting takes practice, so the more we can support quit attempts, the more successful tobacco users will be.

As we continue to address tobacco use and its dangerous impacts among our community, we know much of the work has been done to address cigarette use. Our next battlefield is electronic-cigarette/ vaping products and youth. And, in our rural communities, smokeless tobacco rates are far higher than in the rest of the state. We need to apply what we've learned from the youth cigarette fight to this next chapter of war.

### **Butt Litter**

The month of August was Butt Litter Clean Up Month. The Franklin Grand Isle Tobacco Prevention Coalition partnered with RiseVT, Friends of Northern Lake Champlain, and the Northwest Solid Waste District to pick up and recycle butts during 8 events in 6 communities. 9,030 butts were picked up at Alburgh School, Enosburg Town Recreation Fields, Richford's playground and fountain parks, St. Albans City's Downtown area, St. Albans Town's Bay Park, and Swanton's Marble Mill Park and Village Green. Butt litter clean ups are a great way to raise awareness about the quantity of smoking happening in our community gathering and recreation spaces, the danger that tobacco litter poses to our environment, and to work with community leaders to find solutions decreasing litter and dangerous secondhand smoke exposure.

### **Building Capacity for Treatment and Recovery**



This year, Northwestern Comprehensive Pain marked several milestones on the path toward strong community care for addiction patients. The practice added two new physicians as well as additional clinicians trained in mental health, working hard on care coordination for patients and launching a new toxicology service.

Dr. Ryan Herrington and Dr. Suzan White both joined the practice this year, seeing patients in the Catherine Street office. Dr. White graduated from the University of New England's College of Osteopathic Medicine and did her residency training in Psychiatry at Berkshire Medical Center. Dr. Herrington earned his medical degree at the University of Virginia in Charlottesville, Virginia, and his Masters in Public Health from the Ohio State University of Public Health in Columbus, Ohio. Together, with Michelle Kearney, PA, these practitioners form the core of a strong team in a practice focused on comprehensive pain management, including addiction treatment.

Dr. White's psychiatry training has been particularly helpful as it gives pain management and addiction patients quick access to mental health services from a healthcare provider they already know and trust.

Northwestern Comprehensive Pain also added staff to give greater capacity to provide onsite crisis care for mental health issues, supplementing the support of the

Howard Center for this type of care. The practice now has a full time Licensed Alcohol and Drug Counselor (LADC) onsite, and will soon be adding another full time counselor.

Also, the practice will be hiring another full-time registered nurse as part of the Medication Assisted Treatment (MAT) program (see related story). In part, these care coordinators help make connections to patient support services for this like transportation or employment.

These innovative advancements reflect the practice's comprehensive approach to treatment. Whether patients need care for chronic pain or for addiction, the care plan must address all aspects of the patient's life to be effective. In an effort to provide more of this wrap-around care, NMC launched Northwestern Screening Services, providing urine toxicology screenings with no appointment necessary. The new office is located at 100 Lake Street, Suite 1 and is open from 7:30 a.m. to 6 p.m. each weekday.

"I'm so proud of this team and the progress we've made this year," said Jill Torrey, NMC's Director of Physician Services overseeing this practice. Looking ahead, Torrey is eager for the coming year's work with the addition of a third physician to the practice and collaboration with BAART, which will open a "Hub," a regional specialty treatment center, in St. Albans in early 2017.

### **Getting Creative with Cancer**

This year, NMC's Diagnostic Imaging (DI) Department worked in creative ways to break down barriers to care and to engage the community around prevention and wellness. The team held special Paint & Prevent events in the Courtyard Café, went out to businesses to offer mammography lunch and learns and attended many community events to spread the prevention message.

The painting workshops were a big hit: A unique twist on the traditional guided painting session held in a restaurant or lounge. With NMC's Paint & Prevent sessions, attendees were offered the chance to get an evening mammogram done during the program, putting the focus on spending quality time on well-being. Breast Care Nurse Navigator Chelsea Mulheron built a Lunch & Learn program which she brought to organizations like Wal-Mart and the Franklin Northeast school district. During these engaging sessions, Mulheron presents a myth-busting mammography presentation as well as providing free lunch, and a mindful coloring activity assessing participants personal risk of breast cancer.

Mulheron also attended community events to raise awareness of breast cancer, the importance of screening and to connect people with transportation and financial assistance if needed.

These exciting outreach activities come in the second year of Mulheron's work as NMC's Breast Care Nurse Navigator. The initiatives are funded in part through grants from the Susan G. Komen Fund as well as a Pfizer Healthcare Charitable Contribution. Mulheron continues her amazing work of supporting women through the process of screening, detection and treatment for breast cancer, see related story on page 16. Mulheron and the DI team have made great progress in improving NMC's rate of patient short term follow-ups after mammography as well as increasing the number of new patients coming in for mammograms.


### Changing Procedures to Ensure Mom and Baby Bonding

Traditionally, mothers who had Caesarian sections were taken to the post-surgical unit to recover while their babies went to the Family Birth Center nursery, explained Deirdre Young, director of Surgical Services at NMC. "A lot of work went into changing things," she said. Now mothers and babies are able to connect right after birth and remain together in the hospital.



### **Investing In Improved Quality of Life**


As a leading healthcare organization and a major employer, NMC is devoted to helping improve the quality of life in our community. Naturally, one may think of the care our staff provides as our contribution towards that end. However, NMC also invests cash, time, and resources (things the Internal Revenue Service refers to as "Community Benefit Investments and links to our non-profit status) into a wide variety of efforts to help take a broader approach to improved quality of life.

NMC is devoted to primary prevention – efforts within our community to keep healthy people healthy so as to avoid illness or chronic disease and reduce the demand for costly treatment. We are also devoted to secondary prevention - working with people who have chronic conditions to better self-manage their health and avoid higher healthcare costs. The RiseVT community campaign to embrace healthy lifestyles has had an amazing year! Over 16,000 individuals, 46 businesses, 12 schools, and 4 childcares have connected with RiseVT as our community enjoys ongoing personal, policy, and infrastructure steps towards better health. RiseVT is overseen by the Community Committee on Healthy Lifestyles, which is co-chaired by NMC CEO Jill Bowen and VT Department of Health District Director Judy Ashley. In addition to the local excitement, RiseVT has garnered statewide attention (with a group of stakeholders discussing how to expand the effort) and international attention (with EPODE International – a leader in the prevention of childhood obesity -- rating our efforts highly and beginning to assist us in enhancing our efforts). With the completion of the state SIM grant program, NMC now becomes the primary funder of the RiseVT effort. In addition, NMC funds ongoing work in tobacco prevention, diabetes self-management, healthier eating and a significant portion of the Healthy Roots Initiative, the emerging best-practice approaches to supporting healthier lifestyles in the new Lifestyle Medicine Clinic

led by Medical Director Elisabeth Fontaine, MD, and events such as the wonderfully popular "Healthy Hearts On The Move" fair which drew over 500 attendees in its fourth year! Even after subtracting the portions covered by grants or revenue, NMC invested over \$2 million in FY'16 in primary and secondary prevention efforts such as these!

In addition, NMC staff take an active role in our community – volunteering for causes, participating in fundraisers, serving on non-profit boards, holding municipal offices, leading youth activities, etc. NMC itself also directly supports many important partners and in alignment with our Community Health Needs Assessment and other pressing priorities facing our community, NMC financially supports the events and/ or efforts of many organizations, including:

All of these donations, NMC's funding of primary and secondary prevention, and the absorption of the underfunding of state and federal health programs (such as Medicaid, which the IRS classifies as a formal community benefit investment), combine to account for more than 10% of our revenues for the year. It is a remarkable investment in community benefit that our Board makes to help advance efforts to improve the health and quality of life in our community.



### Navigating Uncertainty Strategically

There is significant uncertainty within healthcare as national reform continues to unfold, as Vermont's pursuit of an All-Payer Model progresses, and as the political landscape surrounding each of those efforts to restructure how hospitals and physicians are reimbursed for care provided. To better ensure that NMC is properly positioned to meet the changing, growing, and ongoing needs of our community, our Board, Medical Staff, and Leadership worked through a strategic planning process to focus our efforts over the coming three years. Our plan is built upon the community health needs assessment and an extensive analysis of demographics, quality metrics, utilization trends, advances in medical care, financial trends, and opportunities for partnership. The plan was refined based on input from staff, providers, volunteers, and community members.

As a result, we will be strategically positioning NMC for the future by working with our medical staff and community partners to refine and advance primary care, surgical specialty care, mental health, medical specialty care, and population health. We will continue our strategic efforts relating to providing exceptional care, valuing our staff and our medical staff, and achieving a sustainable operating model. Our strategic plan and annual operating plan contain detailed initiatives, timelines, specific goals, and measurable indicators of progress. Through all of this, we can best ensure that NMC is properly prepared for whatever changes may come so that we can continue our mission of providing exceptional care for our community.

### **Exceptional ... the Campaign** for Northwestern Medical Center

NMC is in the midst of a capital campaign to raise \$2.5 million in support of the hospital's vision for the future of our community's healthcare. That vision is taking concrete shape on NMC's campus as we complete a historic expansion we call our Master Facility Project. The Exceptional capital campaign supports the effort to adapt our aging infrastructure for the future.

Community support for the campaign so far has been tremendous. That support reflects the desire by local individuals and organizations to be a part of this historic advancement at the hospital.

### Expanding the Options for Medication-Assisted Recovery

Over the past several years, the State of Vermont has experienced a dramatic increase in opioid disorder prevalence, opioid-related overdose deaths, and a rapid escalation in opioid treatment admissions across all health care sectors. In 2015, NMC worked with VT Department of Health, Dartmouth College, Dartmouth Hitchcock Medical Center, Rutland Regional Medical Center, West Ridge Center, and Chittenden Clinic to secure a three year federal grant from the Substance Abuse and Mental Health Services Administration.

The grant provides NMC with nearly \$200,000 annually to provide accessible, effective, comprehensive, coordinated care, and evidence-based medication assisted treatment (MAT) and recovery support services to individuals with opioid use disorder. Focusing on individuals directly involved in the criminal justice system, child welfare system and those on a waiting list for MAT, the program creates greater connection between NMC Comprehensive Pain, the Department of Probation and Parole, Department of Children and Families, The Howard Center, Franklin and Grand Isle Restorative Justice, and Turning Point.

The grant, which began in January of 2016, has reached 78 new patients. The increase in patients has resulted directly from the work of the MAT Coordinator to improve the referral process between the Howard Center, Department of Corrections and directly from residential programs.

## Master Facility Plan





### NMC's Building for the Future Takes Shape

NMC's campus has been a hive of construction activity as our Master Facility Plan expansions take shape. NMC broke ground on the \$32 million expansion in May with Governor Peter Shumlin giving the hospital high praise at the well-attended ceremony on NMC's front lawn.

As soon as the ceremonial shovels were put away, construction began in earnest with sitework at the back of campus re-configuring the loop of Crest Road to allow for the expansion of the inpatient unit.

In June, NMC relocated two practices from the front of campus into Doctors Office Commons to get ready to demolish their former space and make way for the new Medical Clinics Building. In July, the front entrance was closed for lobby renovations and patients and visitors began using the Conference Center doors to access hospital services.

Throughout the summer months, the footprints and skeletons of the new buildings began to take shape as foundations were poured and steel framework was erected. This exciting and fast-moving construction brings four areas of major improvements:

- A renovated main entrance
- Private rooms for NMC's patients in an expanded and renovated wing
- A new building housing specialty medical clinics
- A new building bringing Urgent Care, Primary Care and Orthopaedics to the front of campus, under one roof.

NMC will finish 2016 with a major construction milestone, reopening the renovated front entrance to the public in December. The rest of the construction continues in 2017, with final completion by year's end. Below is a rough timeline of the milestone dates for 2017:

- March 2017: Med-Surg / ICU Inpatient Unit Expansion Opens
- April 2017: New Medical Clinics Building Opens
- June 2017: Medical Office Building Opens
- October 2017: Renovated Med-Surg Space Opens, fully opening the combined space.

### **Breast Cancer Navigator Supports Area Women**

Heather Brigham and Alana Dion began their fight against breast cancer after their annual mammogram screenings revealed they needed to return for more testing.

Fortunately, Brigham and Dion connected with NMC's Breast Care Nurse Navigator, Chelsea Mulheron. She was with them every step of the way, from that first phone call, through more screenings, radiologist appointments and biopsy procedures to coordination with primary care doctors, oncology consultations, surgeries, chemotherapy, and rehab.

Upon meeting Mulheron, both women were instantly comforted by the positive encouragement and loyal dedication she provided, and continued to deliver, through all the physical and emotional stages of cancer.

"It just makes it easier to get through—knowing there's someone there taking care of it all and you don't have to boggle your mind about it," said Brigham. A large part of Mulheron's job is to make the whole process easier for patients so they can concentrate on what's important taking care of themselves, figuring out how to change their routines (for Brigham, it was farming, and for Dion, running a daycare) and staying strong and positive. As Brigham states, you have to keep living your life despite a diagnosis (and the side effects, such as hair loss, that come along). Dion added of the whole experience, "I truly feel I've had an angel on my shoulder. And," she said, pointing to Mulheron, "now I have an angel here."

It is a proud moment when Mulheron hears that both women spoke candidly, and bravely, about breast cancer. She knows 'this is a disaster in someone's world' and is honored to be a support mechanism to each individual breast cancer patient, making certain they know she's going to help them through.



### Northwestern Physical Therapy: Crafting a Healthy Solution

Jackie Willey is thrilled to be back in pain-free action following a shoulder surgery and physical therapy to correct an injury that kept her away from her work and her passion: hand-made clothing, blankets, gifts and crafts.

Willey, who owns the Craft Nook in Cambridge, sits behind her sewing machine as the needle hums its way through a bolt of cloth. Until recently, her rotator cuff injury made work in her shop a difficult and painful experience.

She spent two years in pain. She couldn't lift her arm up, couldn't place merchandise onto high shelves, had trouble getting dressed and even cut her long hair so that washing and styling it was easier.

Her surgery early this year went well, but credits her quick recovery to the physical therapy she gets from Sarah Nielsen, of Northwestern Physical Therapy.

"Sarah has helped me like you would not believe," Willey said. At her first visit to her doctor following the surgery, he was amazed at her progress, she said. She is excited to go back again and show him how far she's gotten in just a few months. Willey said the physical therapy sessions are so effective because Nielsen takes the time to develop a plan of exercises that fit her needs, and work well for her. She said that Nielsen makes it simple, highlighting handy printouts for Willey to reference when she's exercising at home, and checking on her form and her progress at each in-clinic session. Nielsen is also friendly, approachable and supportive, making the program something Willey is eager to work on.

Willey's store is filled with brightly-colored American Doll clothing, blankets, handbags, toys, gifts, and many more hand-made, one-of-a-kind creations

Demonstrating her work around the shop, Willey can't contain her excitement at the simple action of raising her arms overhead, reaching for a clothes hanger, and running her sewing machine. "I'm doing really well," she said. Although she knows a full recovery can take up to a year, the frustrating limitations she dealt with are behind her, and she looks forward to sewing up the rest of her recovery.


