## NMC's New Buildings Start to Take Shape

Structural steel for NMC's construction projects was erected in August, allowing campus visitors to get a glimpse of the shape of things to come. The first steel put up was for the expansion of the inpatient wing at the back of campus. That Med-Surg unit expansion will allow for private rooms for all NMC's patients.

The next steel to go up was for the porte cochere at the new main entrance. This roofed structure will be larger than at the old entrance, allowing patients and visitors much easier access to the drop off and pick up point at the front doors.

In addition to the steel frame work progress, much work on the foundations of NMC's three new buildings was completed in August and September. Footings, foundations were poured for the inpatient expansion as well as for the new Medical Clinics Building and the Medical Office Building at the front of campus.

Patients and visitors continue to use the Conference Center entrance as the main point of access for all hospital services. Keep in mind that the Outpatient Lab moved out of the main hospital during construction, and patients needing bloodwork should go to Doctors Office Commons #1. Another relocated service is Northwestern Cardiology/Pulmonology which is temporarily housed in Doctors Office Commons #10 until that practice moves into the new clinics building.

Looking ahead, the main entrance will reopen in December of this year, allowing patients and visitors front-of-campus parking and access once again to the main building. Construction on the new buildings will continue through much of 2017 with the opening of the new inpatient wing being the next major milestone opening.

Jackie Willey is thrilled to be back in pain-free action following a shoulder surgery and physical therapy to correct an injury that kept her away from her work and her passion: hand-made clothing, blankets, gifts and crafts.

Willey, who owns the Craft Nook in Cambridge, sits behind her sewing machine as the needle hums its way through a bolt of cloth. Until recently, her rotator cuff injury made work in her shop a difficult and painful experience.

She spent two years in pain. She couldn't lift her arm up, couldn't place merchandise onto high shelves, had trouble getting dressed and even cut her long hair so that washing and styling it was easier.

Her surgery early this year went well, but credits her quick recovery to the physical therapy she gets from Sarah Nielsen, of Northwestern Physical Therapy.

"Sarah has helped me like you would not believe," Willey said. At her first visit to her doctor following the surgery, he was amazed at her progress, she said. She is excited to go back again and show him how far she's gotten in just a few months. Willey said the physical therapy sessions are so effective because Nielsen takes the time to develop a plan of exercises that fit her needs, and work well for her. She said that Nielsen makes it simple, highlighting handy printouts for Willey to reference when she's exercising at home, and checking on her form and her progress at each in-clinic session. Nielsen is also friendly, approachable and supportive, making the program something Willey is eager to work on.

Willey's store is filled with brightly-colored American Doll clothing, blankets, handbags, toys, gifts, and many more hand-made, one-of-a-kind creations. Demonstrating her work around the shop, Willey can't contain her excitement at the simple action of raising her arms overhead, reaching for a clothes hanger, and running her sewing machine. "I'm doing really well," she said. Although she knows a full recovery can take up to a year, the frustrating limitations she dealt with are behind her, and she looks forward to sewing up the rest of her recovery.

## NMC Kicks off Capital Campaign

St. Albans, VT (September 9, 2016) — Northwestern Medical Center publically launched its Capital Campaign at a kickoff event Tuesday, September 6 held at the Bliss Roof of the St. Albans Museum.

Lisa Weaver, Supervisor of ICU, Med-Surg and Respiratory Therapy, is making a generous donation to NMC's Capital Campaign naming a private patient room for her children Ashley and Grant Simard. While her donation helps make possible impressive physical renovations, she says her gift is more about communicating her pride in NMC and her love for her children.

"This expansion is more than the physical renovations," says Weaver. "We are building a future for our community. A place where our community members know that we go above and beyond, that we care about their health and their lives, and will always do our best to provide exceptional care."

Weaver is intimately familiar with the complexities of healthcare. Her oldest child Ashley was diagnosed with Rett Syndrome which has robbed her of her speech, mobility, and use of her hands. It has left Ashley with seizures, cardiac and respiratory issues, and chronic pain. She describes Ashley, 28, as a silent angel, who has taught her about unconditional love, acceptance and what truly matters in life. She describes her son Grant, who is 26 years old, as an inspiration in his compassion and love for his sister, and his willingness to put her needs first in so many situations.

"I am blessed to have such wonderful children. I am happy to be able to make this donation in honor of the two most important individuals in my life," says Weaver.

This honor for her children also evokes strong feelings and special memories about the local community and NMC. Weaver's grandmother volunteered at Kerbs in the 70s and Weaver often accompanied her to the hospital when she was young. A resident of St. Albans, she has worked at NMC since 2011. As a lifelong resident of the area, she remembers when NMC looked substantially different than it does today, and she is eager for the transformation that is currently underway.

"Being a nurse at NMC has special meaning to me. I feel pride in being able to say I work at NMC," she says. "This community has been wonderful to my family." While she says she felt lost at times, and struggled with her daughter's diagnosis and her family's coping with it, Dr. Fred Holmes and other caregivers provided her with lifelines.

"I have been blessed to have such wonderful caregivers who have been with my family through many tough times over the years, and who have been committed to both of my children in many ways" she says. Support and care like that can never be repaid, she said, but can certainly be honored in lasting ways.
